Racial Justice Program: Advancing racial justice is one of the core missions of the YWCA and integral to everything we do. All of our programs and services are designed to address disparities that impact communities of color. In FY 20/21, our racial justice department hosted an annual weeklong STAND Against Racism Week in the community, regular Racial Justice Workshops, three 21 Day Social and Racial Justice Challenges, a weekly virtual racial justice hangout hour, and periodic community discussions and virtual events. We also revamped and relaunched the Racial Justice Workshop by expanding the workshop from one 90-minute workshop to a three-part (90-minutes per session) series; allowing for more in depth education, awareness building, and engagement of participants. Last year, over 1500 people participated in our Racial Justice Workshops and 21 Day Social and Racial Justice Challenges. In addition, we continued to support the Racial Justice Coalition through fiscal sponsorship and staff support from the YWCA's Racial Justice Advocate position.
